



Ukubhekisiswa kohlelo lokuthenga umuzi

Ukuba nomuzi kuyinto enkulu kakhulu empilweni yabantu abaningi. Futhi kunesizathu esenza imakethe yezindawo zokuhlala iqhubeke minyaka yonke nokuheha abantu abaningi abaqalayo ukuthenga - okuzinzuzo eziphathelele nesimo senhlalo nangokwengqondo, zokuba ngumnini muzi.

Ukuba nomuzi kuyindlela yokulondoloza nokwakha ingcebo esikhathini eside ngenxa yokuthi ngokuvamile intengo yezindlu iyakhula esikhathini eside, ngakho-ke ngesikhathi abantu bekhokhela imalimboleko yemizi (ibhondi) yabo basuke bekhulisa imali abayilondolozile, kanti futhi ngesikhathi yenyuka intengo yendlu, bathola imbuyiselo ethe xaxa.

“Umgomo” wokuba nekhaya emphakathini ukhuthaza abanikazi bemizi ukuba babe nentshisekelo ngezindawo nemiphakathi abahlala kuyo, bese bebamba iqhaza emizamweni yokuvikela nokuthuthukisa leyo miphakathi yabo.

Kunezinhlalo ezahlukeni zemizi umuntu angakhethe kuzona, ngakho-ke uma ukhethe uhlobo lomuzi oluhambisana nezidingo zakho noma zomndenani wakho, yenza isiqiniseko sokuthi uwuqonda kahle umehluko phakathi kwezindlu ifreehold; sectional title; kanye ne-share-block:

- Ukuthenga indlu ezimele, ifreehold, kusho ukuthi umuntu uthola ilungele eliphelele lokuba ngumnikazi wendawo, kuhlenganisa isakhiwo nomhlaba okwakhiwe kuwo. Lolu hlobo lwezindlu luhlenganisa izindlu ezizimele qequelele (free-standing), yilezo ezakhiwe eqoqweni lezindlu ezisendaweni ebizelwe ezibizwa nge-cluster house, njalo njalo.
- Indlu ebizwa nge-sectional title isho ukuthi umuntu usuke engumnikazi wengxenyana ethile noma iyunithi, ezindlini ezakhiwe zabiyelwa ndawonye kwi-complex. Kulolu hlobo usuke uthenga leyo ngxenyana noma iyunithi okungeyakho, futhi ukhokhela nendawo yangaphakathi engakanyiwe esetshenziswa wumphakathi wonke ohlala lapho. Izindawo zokuhlala ezikwi-sectional title zihlenganisa izindlwana ezincane (mini sub-type houses), izindlu ezihlangene ngodonga (semi-detached houses), yizindlu eziyizitezi ezibizwa ngama-townhouse, amafulethi kanye nezindlu ezihamba ngambili ezihlangene ngodonga kodwa ezinezindawo ezahlukeni zokungena (duet houses). Ngaphambi kokuthenga uhlobo lwendlu eyi-sectional title funda imithetho elawula ukuphathwa kwaleyo ndawo (body corporate rules).

- Ibhilidi elibizwa ngokuthi ishare-block kanye nomhlaba okwakhiwe kuwo ngokwenkampani ethile. Leyo nkampani inenani elithile lamasheya efulethi ngalinye elikulelo bhilidi. Bambalwa kakhulu ababolekisi bemali abakhipha imalimboleko yokuthenga ifulethi kulolu hlobo lwebhilidi, kanti labo abayikhiphayo imalimboleko bavame ukubiza imali yediphozithi enkulu, babize nenzalo yemalimboleko enkulu kunalayo abayibiza kulabo abasuke bethenga ifulethi elikwi-sectional title.

Ukuthenga umuzi kuwuhlelo oluhlenganisa izinto eziningi, kodwa ukuqonda kahle ngabantu ababalulekile ababamba iqhaza ohlelweni lokuthenga umuzi kungakusiza. Abanye balabo bantu ababalulekile yilaba:

- **Ama-ajenti ezakhiwo nomhlaba (estate agent):** ngokuvamile osuke edayisa uqasha i-ajenti ukuba ikhangise futhi imdayisele impahla. Usuke ezoyikhokhela imali ethile okusuke kuvunyelwene ngayo, ngokuvamile eba yiphesenti lentengo yempahla esuke idayiswa. Kuvamise ukuthi i-ajenti kube ngumuntu owazi kabanzi ngendawo futhi onomlando omuhle. I-ajenti kufanele ikhangise ngempahla ezindaweni okukhangiswa kuzo, futhi ihehe abantu abangase bathenge. Iphinde futhi ibe wumxhumanisi wezingxoxo phakathi kodayisayo nothengayo ukuze baneliseke bobabili. Ngemuva kwalokho, ibheka futhi iqaphe uhlelo lonke lokudayiselana, kusukela esicelweni semalimboleko yokuthenga kuze kuyofika ohlelweni lokushintsha kobunikazi bempahla, isuka egameni lodayisayo iya egameni lothengayo. Nakuba kungavamile ukwenzeka kodwa umthengi naye angayiqasha i-ajenti ukuba imfunene umuzi odayisayo.
- **Umhlinzeki wemalimboleko yendlu:** lesi yisikhungo sezezimali esikusiza ukuba ukwazi ukuthenga indlu ngokukunikeza imalimboleko. Kungenzeka sikhokhele ingxenye noma siyikhokhe yonke intengo yomuzi. Abahlinzeki bemalimboleko yokuthenga umuzi banemibandela ehlukene yokubolekisa ngemali, ngakho kuyasiza ukubheka abahlinzeki bemalimboleko abehlukeni ukuze uthole ongakunika okungcono kakhulu.
- **Abameli:** kuba khona ummeli obizwa nge-conveyancing attorney, oqokwa ngosuke edayisa. Umsebenzi walo mmeli wukususa impahla egameni losuke edayisa, ayibhalise egameni losuke ethenga. Kuphinde kube khona ummeli obizwa nge-bond attorney, oqokwa ngumhlinzeki wemalimboleko yomuzi, kanti yena okwakhe ukubhalisa isikweletu esisha egameni losuke ethenga, acishe isikweletu sodayisayo uma imali yaleso sikweletu isikhokhwe yonke.
